

Auction T&C

1. Bidders participating in EZ Auctions are permitted to:
 - a. Inspect the cars at the prescribed time and venue provided by EZ Auctions and to make independent verification with authorities whether any summons were issued, accuracy of the details, registration numbers, make, model, specifications, year of manufacture and relating particulars so that the Bidder is satisfied with the condition and status of the cars before bidding.
2. Bidders have read, understood and agreed to be bound by these terms and conditions:
 - a. Bidders are participating in their own free will and have entered the Auction Premises at their own risk. EZ Auctions will not be held liable for any personal injury, death, loss, damages or liability that any party may suffer when participating in such Auctions;
 - b. Vehicles are sold on an “As Is, Where is” basis with no warranties and are not guaranteed to pass road worthy inspections by local governing bodies;
 - c. Cars sold do not include the vehicle license plate numbers, and the buyer is required to grant access to the vehicle(s) required by Jabatan Pengangkutan Jalan Malaysia (JPJ) for inspections pertaining to the retention of license plate numbers by previous car owners;
 - d. Full settlement of the balance purchase price as well as the buyer’s premium and taxes within (7) Calendar Days;
 - e. EZ Auctions will charge a fee of RM50.00 per vehicle, per day should a vehicle be left at the warehouse beyond (7) days pending payment settlement;
 - f. To carry out Puspakom B5 inspections, the bidder must provide and submit to EZ Auctions via email: ezauctions.my@gmail.com (3) three pictures of vehicle before paintwork and (3) three pictures of vehicle after paintwork;
 - g. The seller has the sole discretion to refuse to surrender the vehicle certificate if it is in the seller’s opinion that the pictures provided are inadequate in determining the authenticity of the vehicle in question;
 - h. Subject to a bidder winning more than one vehicle, EZ Auctions may at its sole discretion decline to release to the winning bidder one or more vehicles until all vehicles won by the winning bidder has been fully paid;
 - i. A transaction will be deemed as null and void if a vehicle’s remaining balance is unpaid for (14) fourteen calendar days after the date of the auction;
 - j. The seller permits a (90) ninety-calendar days grace period for the winning bidder to repair and arrange for the transfer of ownership. The grace period starts on the first day after the auction and the winning bidder must submit photographs of the repaired vehicle stipulated in clause – Failing which, the seller has the sole discretion to refuse to provide transfer documentation to the winning bidder for failing to provide the necessary photo documentation within the grace period;
 - k. The Buyer will bear all inspection and transfer costs;
 - l. Buyers are not entitled to claim for a refund from EZ Auctions under any circumstances after full settlement of the purchase price. Any claims shall be brought directly to the Sellers;
